1.2. RECOMMENDED USE AND RESTRICTIONS ON USE

This product is intended for use only by adults 21 or older. For lawful use only. This product is concentrated and should not be used undiluted. Not for use with tobacco or nicotine. Avoid contact with the skin, eyes, wood surfaces, and fabrics. Keep out of reach of children and pets. Consumers should determine and conduct their own safety standards and testing. Appropriate warnings and safe handling procedures should be provided to all handlers and users, taking into account the intended use and the specific conditions and factors relating to such use in accordance with all applicable laws and regulations.
