#### **1.2. RECOMMENDED USE AND RESTRICTIONS ON USE**

This product is intended for use only by adults 21 or older. For lawful use only. This product is concentrated and should not be used undiluted. Not for use with tobacco or nicotine. Avoid contact with the skin, eyes, wood surfaces, and fabrics. Keep out of reach of children and pets. Consumers should determine and conduct their own safety standards and testing.
